ABOUT AICCAZ

The American Indian Chamber of Commerce of Arizona (AICCAZ) was founded in 1995 and incorporated as a non-profit organization in 1996. The focus of the Chamber is to provide a format for American Indian entrepreneurs to promote their business, for corporations to connect with American Indian businesses, to act as a liaison on tribal economic development issues and to offer the best in resources, training and networking for the American Indian business. AICCAZ offers our members the opportunity to exchange ideas and information with business owners throughout the state.

MISSION OF AICCAZ

The mission of the American Indian Chamber of Commerce of Arizona is to *provide a pathway for business success by creating inclusive networks in and out of Indian country.* AICCAZ does this by serving as the voice of business, providing opportunities and being a champion for a strong community.

BOARD MEMBER RESPONSIBILITIES

The Board of Directors develops an annual strategic work plan and ensures that opportunities exist to bring businesses together with Indian Country through planned events such as bimonthly luncheons, socials, and golf tournaments. The AICCAZ partners with organizations to develop and offer programming to further fulfill our mission. As a working board, committees are formed to advance the work of the chamber. Each Director's participation in the Chamber is a vital investment resulting in a positive climate fostering business.

All Directors must:

- 1. Regularly attend Board meetings, held 4 to 5PM on the second Thursday of the month
- 2. Be a current member of the AICCAZ in good standing
- 3. Participate on (a minimum) of one committee
- 4. Attend the majority of Chamber events
- 5. Serve as a steward of the Chamber by attending other events on behalf of the Chamber with dignity and respect
- 6. Expect a minimum of 5 hours per month dedicated to the Chamber
- 7. Respond to Chamber communication quickly
- 8. Raise the visibility of the AAICAZ through bringing on new members, sponsorships and other fundraising activities

The Board of Directors has authority and is expected to make decisions in an expedient and informed manner. This is necessary to effectively carry out the business of the corporation and fulfill the mission.

DIRECTOR TERMS

- 1. Board terms are two-year terms that begin in January
- 2. A Director can renew for two additional consecutive terms (for a total of up to 6 years)
- 3. Past Directors are eligible for future membership by submitting an updated application.
- 4. Directors will be considered for membership of the Board based upon this schedule:

December 7th, 2021: Deadline for applications at 11:59PM December: Vetting process Early January, 2021: Approved Directors notified January 13, 2022: First meeting for New Board of Directors

Board Meetings are currently held monthly on the second Thursday of the month from 4-5pm
